### RACES

- Reviewed breaking horses at the start – #5 Fashion Contender (Tyler Jones) breaks and causes interference to #3 Willy Strike (Tyler Borth) after the start. #5 finished 6<sup>th</sup> placed 10<sup>th</sup> for interference while on a break.

Race 2 – All Clear

Race 3 – Inquiry – Reviewed the break by #1 D A Alice (Tyler Jones) before the start – did not reach the Fair Start Pole, Refund #9,298. #1 pulled up at the quarter, must qualify for Performance. The horse was placed on the short-term Vet's list (lame) by Dr. Ballinger following the race.
