RACES

Race 1 – All Clear

Race 2 – All Clear

Race 3 – Inquiry – Reviewed pylons on #4 Camara Moment (Doug McNair) around the final turn, finished 1st. The low pan video shows #4 strikes two pylons (not inside) and then races inside two consecutive pylons. #4 was not lapped at the finish by #1 Ron (Phil Hudon). No violations of the AGCO pylon rule by #4.

- Following Race 4, a Place Photo was displayed on TV and Announcer Ken Middleton explained AGCO Rule 18.08.02(a) and that to be 'lapped on' the nose must be on the hind

quarter of the horse who was inside the pylons. In this case, the nose of #1 Ron was only to McNair and therefore not considered 'lapped on'.

Race 4 – Reviewed pylons on #4 Troubles A Brewin (LP Roy) in the stretch, finished 5th – #4 strikes one pylon, races inside one pylon and then strikes one pylon. No violations of the AGCO pylon rule by #4.

- Reviewed racing around the final turn – #10 Back Pocket Miki (Sylvain Filion) is sitting third along the rail and moves out into the path of #1 Notorious Hanover (Jody Jamieson), which forces #1 three-wide. #1 finishes ahead of #10 so no placings were needed, #1 was charted with interference.

Race 5 – Inquiry – Reviewed pylons on #5 Ario Hanover (LP Roy) around the final turn, finished 2nd. The video shows #5 races inside one pylon and hits multiple pylons around the final turn. No violations of the AGCO pylon rule by #5.

- Reviewed racing in the stretch between #2 Mappos Lion (Paul MacDonell) and #9 Woodmere Stealdeal (Jonathan Drury) – no violations or placings needed.

Race 6 – All Clear

Race 8 – Reviewed the break by #10 Gentleonmymind (Colin Kelly) before the start – horse was well inside the Fair Start Pole.

Race 9 – Reviewed the stretch and racing between #6 American History (Doug McNair) and #7 The Longest Yard (LP Roy) – #6 is clear of #7 and there is no interference.

Race 10 – Inquiry – Reviewed racing in the stretch between #2 Rockme Rollme (Bob McClure) and #4 Toronto (Ed Hensley). Hensley stated his horse was bearing out on him and he was not bothered at all by #2. The video shows #2 is still clear of #4 and Hensley does not have to check his horse, nor is his horse impeded. No placings.

- #1 Taylors Credit (Natasha Day), #6 Sea Laird (Tyler Borth) and #8 Mad Man Hill (Jody Jamieson) were charted with interference due to the break by #5 Beyond Better (James Macdonald) at the half. No placings needed.

Race 11 – All Clear

Race 12 – Spoke with Bob McClure regarding the favourite, #5 The Boss Said. McClure stated the race didn't unfold at all how he anticipated. At the half, there were horses already parked out and he felt shooting up the rail would be better than being fourth or fifth-over from where he was sitting. At the top of the stretch the rail opened as horses began fanning out; however, #10 Howies Man (LP Roy) came to a complete stop in front of him and he had to check his horse hard. Once he got around #10 the horse closed along the rail and finished 6th. #5 was charted with interference in the stretch.
