Race 1 – All Clear

Race 3 – Inquiry – Reviewed racing at the 3/4s between #1 Tesla Power (Sylvain Filion) and #7 Sweetest Belle (Chris Christoforou). The video shows #1 starts moving out of the two-hole but Filion takes the horse back to the rail and does not cause interference to #7. No violations by #1.

- #9 Procrastinator was checked by Association Vet Dr. Ballinger following the race and placed on the short-term Vet's List (sick).

Race 7 – Inquiry – Reviewed racing in the stretch between #5 Rosies War Bonds (Ed Hensley) and #8 Tymal Tarot (Jody Jamieson). The front tower shows #8 is trying to pass #5 on the inside and the two horses hook wheels. Hensley stated he was trying to close the inside rail and as a result his horse may have come down a little. This happened as #8 was advancing and caused the wheels to hook. There was no interference to trailing horses; #8 was not at fault to warrant a placing and no change was made to the order of finish. Both #5 and #8 were charted with interference.
