- Ruling #2058294 issued to Trainer Mark Goddard for a Certificate of Positive Analysis for the Class 3 drug Arsenic (quantified at 1167ng/mL) on the horse Villefranche AS from Race 2 on November 4, 2022. Tag #53 22308301. Mr. Goddard accepted a settlement agreement of a 15-day full suspension (March 6 – 20, 2023) and \$1,000 monetary penalty.

RACES

Race 1 – Inquiry – Reviewed the break by #3 Barrett Hanover (Doug McNair) before the start – horse was not inside the Fair Start Pole, Refund \$42,904.

Race 2 – Inquiry/Accident at the 3/4s – #6 Tour Champion (Jody Jamieson) is sitting in the two-hole and steps on the wheel of #7 Control The Smile (Travis Cullen), which causes the horse to make a break and a chain reaction to trailing horses. #4 Rangers Shadow (Beau Brown) runs into the back of #6 and #9 Smokin Mo (Nick Boyd) runs into the back of #7 and falls to the track. #5 Dream With Me (Phil Hudon) and #8 Bettorholdontight (Tyler Jones) also suffered interference breaks. #6 finished 7th placed 8th and was disqualified. All horses and drivers were reported OK.

- #5 suffered an interference break after the start due to the break by #8. #5 also finished the race with broken equipment (overcheck and hopples).
- No inquiry video to be posted. Judges will follow up with Mr. Jamieson.

Race 3 – Trevor Henry (#1 P L Octavius) will be in for a film review on Monday for his urging in the stretch. Race All Clear

Race 4 – Tyler Jones (#3 Delightful Feeling) will be in for a film review on Monday for AGCO Rule 22.19 (failing to keep both feet in the stirrups). Race All Clear.

Race 5 – All Clear

Race 6 – Doug McNair (#4 Captain Q) will be in for a film review on Monday for AGCO Rule 22.19 (failing to keep both feet in the stirrups) and a breach of probation. Judges will also be speaking to Mr. McNair regarding his actions following the race. Race All Clear.

Race 7 – All Clear

Race 8 – Reviewed racing in the stretch – #7 Cadillac Bayama (LP Roy) bears out in the stretch and interferes with #3 Southbeach Hanover (Bob McClure). #3 was charted with interference; no placings needed.

Race 9 – James MacDonald (#3 So Much More) – \$300 monetary penalty – did fail to keep both feet in the stirrups. AGCO Rule 22.19 (2nd offence within six months). Ruling #2058363.

Race 10 – Reviewed the second quarter (:26.4, :57) – #6 Stone Carver (James Macdonald) is parked and clears to the front at the 3/8ths, no violation of AGCO Rule 22.05.01(k) (fail to set a pace comparable to the class) by Mr. MacDonald.

Race 11 – #9 Control The Power (James Macdonald) finished distanced and must qualify for Performance, Tr. David Snowden. The horse was checked by Association Vet Dr. Ballinger following the race and placed on the short-term Vet's List (sick).
