**Office:**

- Five Ontario Sires Stakes Grassroots divisions for 2YO Colt and Gelding Pacers.
- In Race 3, #2 Sugardaddycontrols (Tr. Daniel Lagace) was a Judges Ineligible scratch as the horse was not eligible to receive Lasix.
- Judges approved trainer transfer of the horse Warrawee Whynot to Rob Fellows.
- Travis Cullen decision from Race 8 on July 8 – The Judges spoke in depth with Mr. Cullen and reviewed previous races of Born A Dragon. We were satisfied with Mr. Cullen's explanation and no further action is needed.

Race 1 – #8 Matters Most (Trevor Henry) finished 8<sup>th</sup> placed 10<sup>th</sup> for an extended break in the stretch.

Race 4 – Reviewed the break by #2 Intense Justice (Chris Christoforou) at the half – horse broke on her own, no violations.

Race 5 – Inquiry – Reviewed possible pylon violation by #9 Cousin Mary (Doug McNair) around the final turn, finished 3<sup>rd</sup> – the low pan video shows #9 races inside four consecutive pylons. #9 finished 3<sup>rd</sup> placed 10<sup>th</sup> for a pylon violation. No penalty to driver McNair, as the horse was running in on him and this is the second week in a row the horse has been placed for a pylon violation in the same spot on the track. Judges spoke to Trainer Jeff Williamson's representative with the horse about making the necessary equipment adjustments going forward.
