- Bob McClure (#3 Lauras Love) – did fail to keep both feet in the stirrups in the stretch. \$500 monetary penalty, 3rd offense of AGCO Rule 22.19 within six months. Ruling #1091360.

Race 3 – Dead heat for win between #2 Shape Shifter (Phil Hudon) and #10 Magic Cape (Michiel Vanderkemp).

- Inquiry #1 – Reviewed racing in the stretch between #2 and #10 – both horses come together; neither horse can be held solely responsible; no placings.
