Race 5 Spoke to James Macdonald regarding his drive on # 6 International Man, the race favourite. Mr. Macdonald stated he got stuck in a horrible spot and didn't want to park the horse first over that hadn't raced since July 1st. He felt that tucking

in and trying to get cover later was a better strategy, but it didn't work out. He admitted it was a bad drive. No further action needed at this time.

Also, # 3 Eden Onthehill (T. Borth) was charted with an equipment break in the stretch and finished with broken trotting hobbles.

Race 6 # 4 Dreamfair Moxy was a late scratch lame by the Commission Vet. # 6 Lancaster Bomber (J. Macdonald) finished with broken equipment (shoe).

Race 7 # 9 Warrawee Xalt was scratched Judges late for Lasix. Trainer Richard Moreau was issued a \$500 monetary penalty for a violation of AGCO Standardbred Rule 35.07. 3rd offence within 12 months of the 1st offence. Ruling 2313452.

Also, reviewed stretch where # 4 White Tiger (J. Macdonald) moves off the rail from 4th. # 6 Spartan General (C. Christoforou) and # 5 All Wrapped Up (T. Borth) were charted with interference. No placings needed.
