STAND

- Film Review of Race 4 yesterday with Rafael Hernandez, Leo Salles and Skye Chernetz was postponed until Thursday.
- Exercise Rider Jefferson Gill informed of \$100 monetary penalty for galloping along the rail on Friday morning. Ruling to follow.
- In Race 5, #5 Master Spy will race with no bar shoe. The change was announced to the public during the early changes.

RACES

Race 1 – #4 Flippin was a late Vet scratch in the paddock. #2 Il Malocchio (Tr. Martin Drexler) suffered from an episode of epistaxis and is ineligible to race for 14 days. Race All Clear.

Race 2 – #5 Cool Kiss was a late Vet scratch in the post parade. #2 Souper Sunshine (Corey Jordan) broke slow. Race All Clear.

- Spoke to Rafael Hernandez (#9 Armstrong) about keeping his hand below his head while urging.

Race 3 – Victoria Stakes, #2 Kaukokaipuu (Jason Hoyte) broke slow. Race All Clear.

Race 4 – Inquiry – Reviewed the start of #3 Mt Logan (Emma-Jayne Wilson). Upon review of the pan and back tower video in slo-mo, it was determined the latch on the gate of #3 opened early and that horse was able to break ahead of the field. The pan video shows where #3 has left the gate while the back tower shows the remaining gates have not fully opened yet. As a result, #3 was declared a non-starter and refunded for gaining an unfair advantage at the start as per AGCO Rule 16.12(b). Refund \$316,474.

- Following the 5th race being made Official, it was brought to the attention of the Stewards that the starting gate on the Inner Turf may have been set in the wrong position. After reviewing the set position of the gate, it was confirmed by maintenance the gate was placed approximately 152 ft further back than the scheduled distance. The running time was correct as the G Max timing system reverts to a 270 ft run up to the start. Stewards contacted Woodbine management and a meeting will be held next week to ensure the markers for the Inner Turf are set properly.
