STAND

- Race Officials spoke to Anthony Pottinger and rider Leo Salles about an incident during training hours yesterday morning. No regulatory action needed.
- Trainer Jason Marrocco arrived late to the paddock with #6 U S Army Corps in Race 1 and was assessed a \$100 monetary penalty. AGCO Rule 11.01, Ruling #1781620.
- Received a security report regarding Jamie Attard. A Review will be held with Mr. Attard next week.
- Jockeys Dylan Davis and Pablo Morales were reminded of the Ontario Urging Rules.
- Spoke with Skye Chernetz about her urging in Race 2 yesterday, no further action required.

RACES

- 109 entries

Race 1 – All Clear

Race 2 – Inquiry and JCOF – #6 Tenpenny Nail (Leo Salles) on #1 Keystone Law (Devon Johnson) in the stretch. Salles stated he was getting inside pressure from #1, who kept coming over and cut him off, which forced him to check his horse. Johnson felt he stayed straight and the outside was causing pressure to #6. The video shows that #1 is not clear of #6 and forces Salles to check his horse. #1 finished 4th placed 7th for causing interference. Review will be held with Johnson tomorrow.

Race 3 – JCOF – #1 Mardene (Keveh Nicholls) on #2 Warwoman (Justin Stein) and #4 No More Diamonds (David Moran) approaching the wire. Nicholls stated that #4 was drifting and came out to him. Stein stated he kept straight through the stretch. Moran stated his horse was running out to Stein's horse but was clear of #1. The video shows that Nicholls checks his horse as #2 and #4 have gone through the wire. His horse appears to have also stepped down to #4, who was coming out, but clear of #1 as Moran said. The video does not support a placing of either #2 or #4 and therefore the JCOF was disallowed.

Race 4 – #4 Spirit Dance (Slade Jones) broke slow. Race All Clear.

Race 5 – #9 Angelou (Luis Contreras) stumbled at the start, prevailed. Race All Clear.

Race 6 – #4 Only At Midnite (Sahin Civaci) and #12 Fortyfiveseventy (Antonio Gallardo) broke slow.

- Reviewed racing at the top of the stretch – #7 A Gal for T J (Jason Hoyte) is running erratic and appears to clip heels with #12.

Race 7 – Selene Stakes (GIII), Race All Clear.

Race 8 – Nassau Stakes (GII), Dead Heat for win between #2 Lady Speightspeare (Emma-Jayne Wilson) and #4 Crystal Cliffs (Rafael Hernandez). Race All Clear.

Race 9 – Marine Stakes (GIII), JCOF – #8 Mannix (Emma-Jayne Wilson) on #1 Ironstone (Ademar Santos) before the quarter pole. Wilson stated #1 wasn't staying in a straight path and was drifting in and off the rail. The horse came down to her around the turn and forced her to check. Santos stated Wilson tried to force herself into the hole, but it was not there. The video shows that #1 appears to remain in the same path and is inconclusive that #1 came in on #8 to warrant a placing. JCOF disallowed.
