Race 1 – Clear

Race 2 – #5 “Beyond Talented” ridden by Shin Civaci was eased through the stretch

Race 3 – Stewards Inquiry and Jockey Claim of Foul (COF) by Rico Walcott aboard #5 “Halo Style” against #4 “Carla’s Honor” ridden by Skye Chernetz for interference approaching the wire. We first received a call from Trainer Patrick Dixon asking us to have a look at the last few strides approaching the wire. Walcott said his horse was still running and the #4 horse came over in his

path, said had to check hard or was going to go down. Skye said she did move in a bit late stretch but never bothered the inside horses. After review, the COF was disallowed, no change.

Race 7 – The Star Shoot Stakes – Stewards Inquiry and Jockey Claim of Foul (COF) by Sahin Civaci aboard #5 "Jill Jitterbug" against #6 "Blind Spot" ridden by Tyler Conner for interference during the stretch run. Sahin said his horse was in full stride when and going to win when the #6 came out abruptly into his path, said he had to check, stopped his momentum. Still came on and only beat me a neck. Tyler said he hit his horse once left handed and she went out with me, grabbed her as quick as I could, thought I was clear at the time. She was a bit green out front by herself. After review, #6 was disqualified from first and placed second behind #5. Review with Tyler after and because he made an effort to correct the situation, it was determined no penalty was required.
