Race 9 – Two Stewards Inquiries, first review of the run down the backstretch involved #1 “October Frost” ridden by Leo Salles and #2 “Palace View” ridden by Sahin Civaci. Leo said he was in there and the number #2 kept coming down until he forced me into the fence. Sahin said I was trying to take back but not quick enough, he was in a bad spot. After review, we disqualified #2 from third position and was placed sixth behind #1.

Second Stewards Inquiry and Jockey Claim of Foul (COF) by Eswan Flores aboard #4 “Mad Mocha” against #6 “Cool Kiss” ridden by Luis Contreras for interference through the stretch. Eswan said the #6 bumped my horse a couple times and impeded my momentum. Luis was unsure of any interference on his part. Said #2 on the inside of me bumped me out coming into the stretch then the #4 was leaning on me late in the stretch. After review, the COF was disallowed. No change
