Race 1 - Clear

Race 3 - #6 "Ladies Rum" ridden by Jose Campos was fractious in the gate and scratched by the official Veterinarian. #1 "Virginia's Legacy" ridden by Skye Chernetz was slow leaving there and never in contention throughout. Mutuel refund on #6 was \$52,241.

Race 4 – Jockey Claim of Foul by riders Leo Salles aboard #5 "Silent Lucidity" and Fraser Aebly aboard #6 "Chelsea Dagger" against #7 "Rockland Express" ridden by Kazushi Kimura for interference through the stretch. Kazushi said I was well clear of the two, may have come in a bit but was clear, inside horse came out. Fraser said he thought the #7 came in but now realizes he went out with his own horse more than he thought. Leo said both the #6 bore out and #7 came in,

he was caught in between and it cost him a position. After review, the Claims of Foul were disallowed.

Race 5 – Stewards Inquiry and Trainer Claim of Foul (COF) by Santino Depaola of #8 "Hey Luigi" along with the rider Alexander Marti. Second COF by Jockey Jodeien Anderson aboard #6 "Phantom Jewel" against #7 "Rock Bullet" with Kazushi Kimura aboard. Kazushi said his horse did go in with him and up against #6 through the stretch, grabbed as quick as I could. Jodeien said the outside horse #7, did come over on him and push him down into the inside horses, had trouble getting his horse off those inside. Alexander Marti said the outside horses came down and squeezed him, the inside horses pushed back and Marti had to check and and get out of there. Ryan Munger said he had to hold his ground best he could because the pressure from the outside was going to push him onto the heels of the eventual winner, nothing more I could do. After review, it appeared the #7 with Kazushi did come in and the result was the four inside him were stacked up. #7 was disqualified from second and placed sixth behind #8.

Race 6 – Stewards Inquiry and Rider Claim of Foul (COF) by Amanda Vandermeersch aboard #10 "Good Soldier" against #9 " Kazushi Kimura for interference through the stretch. Amanda said the #9 came down in front of me and I caught that one's heels, however, now that I see the video, it is apparent the inside horses came out and put me across Kazushi's heels. Kazushi said he stayed as straight as possible, wind is strong but I stayed out. We spoke with Sahin Civaci aboard #7 "Twixter" who said his horse was getting out with him and did go out through the stretch, my horse was shying from the #3 to my inside, did my best to keep straight. After review, it is apparent the #7 did go out through the stretch, pushing horses out which created the situation for Amanda and her catching heels of the #9. A second COF was lodged by Justin Stein aboard #1 "Chairman Layla" against #4 "Social Justice" ridden by Ryan Munger for interference through the stretch. Jus https://youtu.be/Jb-z43jYJVstin said that as Ryan was going by me he came over into my path, I could see Ryan was doing his best but his horse was not responding. Ryan said his horse was laying in with him but thought he was clear of Justin. After review, the second COF was disallowed.
