**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

### Stand:

As a result of the recent AGCO decision of Capsaicin positives wherein horses were to be disqualified from their respective races, a change of eligibility for 4th race #6 Boscobel resulted in the horse being scratched by the Stewards. Boscobel had placed second in a maiden race on September 4, 2020. With the disqualification of the winner of that race Down With Brown for the post race positive, Boscobel is now deemed to be the winner and no longer considered a Maiden, therefore ineligible for the 4th race today.

Race 1, Inner turf, All clear

Race 2, Off EPT Turf, All clear

Race 3, Stewards inquiry, top of stretch #8 C. Husbands, 3<sup>rd</sup>, #2 K. Nicholls 4<sup>th</sup> and #1 J. Stein, upon review of the upper pan, front tower and apex camera angles, #2 is angling off the fence at the top of the stretch and #8 is right on his flank, #8 is forced out to the #1 who has to check to

avoid heels. After speaking with the riders it was determined that #2 did cause the interference and was 4<sup>th</sup> placed 8<sup>th</sup>. A review for all riders involved for tomorrow.

Race 4, #11 Queen Licia stumbled badly at the start, #9 Aventura Traviesa bore out at start, eased around the far turn and stretch, rest ok

Race 5, #9 Coltons Dream eased through the stretch, rest good

Race 6, Inner Turf, Stewards' inquiry, #4, S. Ryan, 1<sup>st</sup> and #5 D. Fukumoto, 3<sup>rd</sup> approaching the finish, upon review of front tower and upper pan camera angles, it is apparent that the room for the #1 on the inside is diminishing, does not appear to be in there prior to #4 coming in. S. Ryan felt there was no room for him to be there and D. Fukumoto stated it was closing as he attempted to go inside. No change made to the order of finish.
