Kazushi said he was trying something different and was gaining on the winner, didn't realize I hit the horse as many times as I did. Mr. Kimura was issued a \$200 monetary penalty for a first offence of the urging rules. AGCO ruling #2369922

Race 7 - #1 "One Last Kiss" ridden by Luis Contreras was fractious in the gate which also affected the #2 "Midnight Mascot" with Rafael Hernandez. Both horses were scratched by the official Veterinarian. Mutuel refund for both horses \$125,822.

Race 9 – The Breeders Stakes – Rider Claim of Foul (COF) by Sahin Civaci aboard #12 "Elysian Field" against #11 "Touch'n Ride" ridden by Kazushi Kimura for interference through the stretch. Sahin said my bad, thought it was Kazushi but now watching the video realize it was me that initiated the issue. Kazushi said the inside horse kept taking me out through the stretch, tried to keep my horse straight. After review, the COF was disallowed, a Notice of Review was issued to Sahin for a review of the incident.

Race 11 – Inquiry into the start involving #3 "Giant One" ridden by Sahin Civaci reared at the start. Sahin said the horse got upset once in there and the Assistant starter did his best to help me. Refund of Mutuels was order on #3 for receiving and unfair start. Mutuel refund \$207,757.

After review, the COF was disallowed.
