Race office error, Race 14, Steward scratch of #3 Cedar Valley. Is a filly in the body of a colts and geldings preferred race that overfilled.

Jockey Jodiene Anderson excused from the remainder of his mounts after the fifth race.

Jockey Luis Contreras issued a three-day riding suspension, from the 10th race on November 28, 2021, first three days of the Woodbine 2022 racing season. TB Ruling #1546704

Race 5, Stewards Inquiry, review of #3 Ethnic Soul, J. Anderson, 1st and #9 Silver Signature, E. Flores, 2nd, coming to the finish and the use of the crop by Anderson. He is trying to use his crop but is having difficulty as the #9 goes out to him and makes contact. There was no evidence to support the allegation.
